Please fill out your order form indicating the days you expect your child to eat. **Return the order form with payment by FRIDAY, 04/19/19. Payment is due when your order is submitted.** We rely on each child's payment to meet our expenses. Keep your menu at home for reference. A lunch count will be confirmed every morning in class. There will be a vegetarian option offered on all meat days. *For critical, last minute needs of the family, a limited number of same day lunches will be available to order.*

Fuente Nueva will be serving peanut and nut free lunches!

If your student has food allergies and requires special meal accommodations, please contact the front office for the necessary forms.

Parents and staff wishing to have lunch must request it from the kitchen in advance, adults pay **\$4.25**.

IMPORTANT! Fuente Nueva participates in the National School Lunch Program. Free and reduced-price meals are available to students who live in a qualifying household based on their Application for Free and Reduced-Price Meals. A new application is required for each school year (one application per household). If you believe your child(ren) may qualify for free or reduced-price meals, **it is important to submit your application to the school office as soon as possible because free or reduced-price meals begin the day we determine your eligibility.** The school only receives reimbursement for these meals from the federal and state programs after the household members are determined to be eligible. It is the responsibility of parents to pay for meals until their application is approved. Applications are available in the school office and may be submitted at any time during the school year. After we receive your application we will send a letter informing you of your status.
